Cost Share Assistance

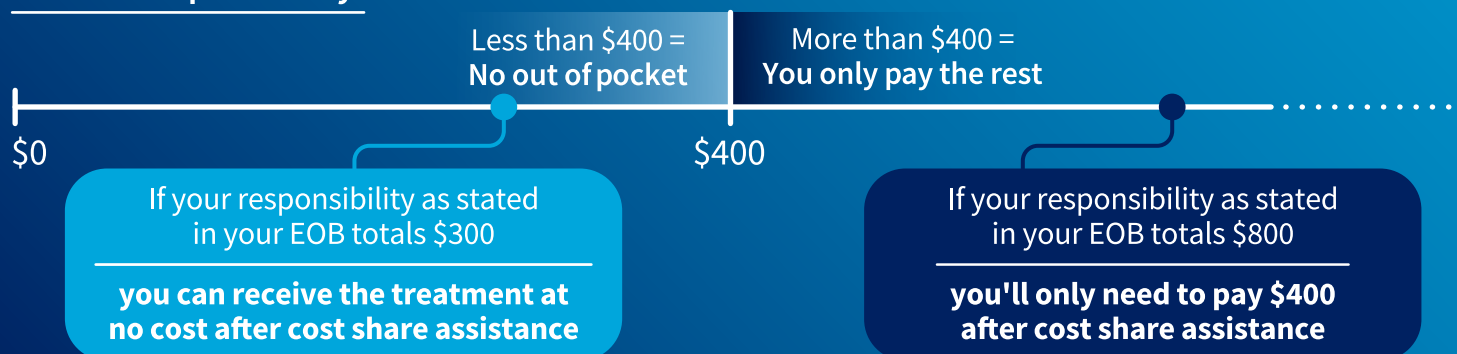
Eligible, commercially insured patients may pay as little as \$0 for AposHealth® through our cost share assistance program. Limits, terms, and conditions apply.*

After becoming an AposHealth® patient, you will receive an explanation of benefits (EOB) from your healthcare insurer stating your cost share, and you'll be paying some of the EOB upfront directly to the clinic. **Please save the receipt.**

Indication

AposHealth® is FDA cleared for treating knee osteoarthritis, to help temporarily reduce knee pain and improve lower extremity function during activities of daily living.

Risks

AposHealth® should be undertaken only under the direction and supervision of a licensed medical provider. Risks include muscle and joint soreness and may require adjustment. Falling is a potential risk.

Terms & Conditions

By participating in this cost share assistance program, you acknowledge that you currently meet the eligibility criteria and will comply with the Terms and Conditions described below:

- Patients are not eligible for this program if they are enrolled in a state or federally funded insurance program, including but not limited to Medicare, Medicaid, TRICARE, Veterans Affairs health care, a state prescription drug assistance program, or the Government Health Insurance Plan available in Puerto Rico (formerly known as “La Reforma de Salud”).
- Patient must have Blue Cross Blue Shield of Massachusetts insurance.
- Eligible patients will be responsible for any amount of cost share above \$400. The amount of any benefit is the amount of cost share owed up to \$400. After the maximum of \$400 is reached, you will be responsible for the remaining out-of-pocket costs. Patient must submit EOB and/or patient receipt for the rebate/cost share responsibility.
- This program not valid where prohibited by law.
- This program is not health insurance.
- Offer good only in the U.S.
- Patient must submit a complete request for reimbursement to AposHealth® within 180 days of initial appointment.
- No other purchase is necessary.
- Data related to your participation in this program may be collected, analyzed, and shared with AposHealth® for market research and other purposes related to assessing AposHealth® programs. Data shared with AposHealth® will be aggregated and de-identified; it will be combined with data related to other Cost Share card redemptions and will not identify you.
